## **Investment Objective and Strategy**

BMO Advantaged Equal Weight Oil & Gas TACTIC™ Fund was established to provide tax-efficient, leveraged exposure to the BMO Equal Weight Oil & Gas Index ETF (TSX: ZEO). The Fund will employ leverage, including through the use of derivatives, to increase its exposure to ZEO to a maximum of 1.33:1 as at the time of borrowing.


## **Underlying ETF**

BMO Equal Weight Oil & Gas Index ETF has been designed to replicate, to the extent possible, the performance of the Solactive Equal Weight Canada Oil & Gas Index, net of expenses. The Fund invests in and holds the Constituent Securities of the Index in the same proportion as they are reflected in the Index. The Solactive Equal Weight Canada Oil & Gas Index includes securities in the oil & gas industries. Constituents are subject to minimum market capitalization and liquidity screens. In addition, each security in this Index is allocated an equal weight rather than a market capitalization weight.

- Provides convenient and efficient equal weight exposure to Canadian oil & gas equities
- Energy is a cyclical growth sector
- Invests in large capitalization equities, including pipelines, resulting in a higher yield than the overall sector
- Equal weighting avoids security concentration


